TRAILERED BOAT STORAGE

Boat storage is also being offered at BYC North for trailered boats that do not require hauling by the Travelift.

- Proof of insurance must be on file with the Club Secretary
- BYC will not be held responsible for theft or vandalism of your boat
- Boats must be stored in designated areas only as directed by the Dockmaster

Trailered boats with a registered length of 22' or less will cost \$15 per foot.

Trailered boats with a registered length of greater than 22' will cost \$20 per foot.

YARD SERVICES

Winter Storage

- Haul boat
- Pressure wash
- Place on blocks and stands (Provided by owner)
- Winter storage season is from November 1st thru May 30th.
- Price is \$42.00 per foot. (Includes re-launching in spring)

Short Haul

- One Day / Emergency Haul
- Lift boat only \$4.00 per foot (Includes re-launching)
- Power Wash \$2.50 per foot

Long Haul & Block

Lift & set boat down \$5.00 per foot (Includes re-launching)

TERMS AND CONDITIONS OF WINTER STORAGE

Boat Owner Agrees To:

- 1. Be prepared to haul and launch his vessel on the scheduled date;
- 2. Abide by club rules pertaining to launch and haul out;
- 3. Maintain full insurance coverage on his vessel at all times during the term of this agreement including "all risk" hull coverage and liability coverage;
- 4. Provide safe and stable stands that are suitable to support his vessel;
- 5. Label the stands with the owner's name;
- 6. Ensure that in washing, sanding, decommissioning, commissioning, and cleaning his boat he will comply with all State and Federal Laws prohibiting discharge of materials that will contaminate the Club grounds, and any other environmental laws, to which Branford Yacht Club is fully committed;
- 7. Empty all holding tanks before placing a boat at the BYC North lot;
- 8. Remove from Club property all hazardous substances such as waste oil, antifreeze, gasoline, diesel fuel, antifouling paints, and residues and dispose of them in an environmentally responsible manner;
- 9. Use a dustless sander with an appropriate shop-vac for sanding;
- 10. Properly bag and dispose of any and all material generated by sanding in an environmentally responsible manner, away from the Club property;
- 11. Limit Power Washing to the removal of slime and barnacles from the boat hull and not for the removal of paint;
- 12. Use Special Care to minimize paint removal when power washing;
- 13. Power wash only in the designated wash area;
- 14. Clean up all residues and debris resulting from boat maintenance work and winter storage and dispose of same as directed;
- 14. Dispose of shrink wrap property off-site and specifically not in Club dumpsters; and
- 15. Refrain from sleeping or living on the stored boat.

GENERAL RULES (BOAT OWNER ACKNOWLEDGES NOTICE AND ACCEPTANCE BY SIGNING BELOW):

- 1. Branford Yacht Club does not provide any security services.
- 2. Branford Yacht Club reserves the right to terminate this Agreement if, in the sole judgment of Branford Yacht Club, the Boat Owner has failed to comply with all of the terms and conditions of this Agreement. In the event that Branford Yacht Club terminates this Agreement, Boat Owner shall be responsible to remove the stored property from the storage facility within seven (7) days of the date on which the Club's Board of Trustees mails written notice, by first class postage, to said Boat Owner.
- 3. The rates specified in this Agreement are solely for the storage/dockage of the type indicated and do not include any repairs, winterization, re-commissioning, covering, uncovering, blocking or cleaning work.
- 4. Boat Owner shall remove the vessel from storage/dockage on or before the termination date of this Agreement. Any vessel not so removed may be removed, relocated and/or stored at Owner's expense at the prevailing posted rates.
- 5. All storage/dockage charges shall be paid prior to departure of the vessel from the boat yard.
- 6. Boat Owner shall be responsible for any oil or fuel spillage from the vessel on land or in the water. This shall include all charges associated with the cleanup, fines, and damages as a result thereof.
- 7. This Agreement contains all terms and conditions of the Agreement between Branford Yacht Club and the Boat Owner. No modification of this Agreement shall be binding upon either party unless such modification is made, in writing, and signed by both Branford Yacht Club and Boat Owner.
- I HAVE READ THE ATTACHED AGREEMENT AND AGREE TO THE TERMS AND CONDITIONS SET FORTH WITHIN I, the undersigned, agree to the terms and conditions of the winter storage agreement with the understanding that a violation of these terms may cause the loss of my storage privilege at the Branford Yacht Club. I further understand that my vessel will not be hauled without the execution of this Agreement and that I, or my representative, must be present when hauling. If I am not going to be present I will advise the Club of the name of my representative.
