Application for Regular Membership

GENERAL INFORMATION

A BYC applicant must provide proof of citizenship and state residency.

Each applicant must be proposed by a regular member in good standing who is willing to vouch for the character and conduct of the applicant. Information from both the applicant and the sponsor are required to complete the applications.

A regular member may propose only one applicant during any six-month period.

It is the applicant's responsibility (not the sponsor's) to complete the "Applicant's Information" portion of the application and return it to a sponsor. The applicant may retain the "General Information" portion for future reference.

The completed application (two forms) should be returned by a sponsor to:

Fully completed applications will be dated when received by the Secretary. They will be acted upon in the order of their receipt as vacancies occur, except when preference is given to sons / daughters of present members or to all vacancies in the club marina.

The applicant's sponsor will be notified when a membership vacancy occurs and the respective applicant is being considered for membership. The sponsor will then notify the applicant.

The membership shall be notified of pending applications to be presented to the board. Members may contact an Officer or Trustee with concerns about any applicant.

The initiation fee, annual dues and any marina fees must be received by the Secretary on or before the applicant meets with the Board of Trustees.

The applicant's sponsor is obligated to accompany the applicant when appearing before the Board of Trustees.

After acceptance by the Trustees, a notice shall be sent to the membership with the list of approved applicants.

A membership vote on the applications shall be held at the next regular membership meeting.

The application will be formally approved or rejected by the membership at the next regular meeting. If rejected, the applicant will receive a full refund of all monies submitted with the application.

The new applicant may not attend any regular meeting until voted into the organization by the membership. As a new member the applicant must complete certain requirements during the first year. The sponsor is obligated to detail these responsibilities to the applicant prior to their meeting with the Board of Trustees.
